RESTRICTIONS ON USE OF SPACE:

OVER THE COUNTER SALES:

Collection of applicable state or regional sales tax is the responsibility of the Exhibitor making the sale.

LIABILITY AND INSURANCE:

MAG Auctions, and the Reno/Sparks Convention Center management or any officers, directors, or staff members of the same will not be responsible for the safety of property of the exhibitors, their agents or employees from theft, damage by fire, accident or other causes, Exhibitors wishing to insure their goods must do so at their own expense.

FIREARMS:

MAG Auctions does not allow weapons at our events. This means firearms and knife blades longer than six inches are not allowed on premises.

FIRE PROTECTION:

Flammable cloth decoration must be flame proofed. All hangings must clear the floor. Electrical wiring must conform to National Electrical Code Safety Rules.
